Revocation of Certain Prospectus-Related Blanket Orders

Background

- 1. Blanket Order A National Policy Relating to a Summary Statement in a Prospectus of Statutory Rights of Action, Withdrawal, Rescission and Damages (the **1983 Order**), which was issued on 5 May 1983 to permit the inclusion in a prospectus of a prescribed summary statement of a purchaser's statutory rights of action or withdrawal, rescission and damages, is superseded by provisions of National Instrument 41-101 General Prospectus Requirements to similar effect.
- 2. Blanket Order *ASC Policy 4.12 Investment Contract Policy* (the **1990 Order**), which was issued on 29 March 1990, provided certain exemptions from the prospectus delivery requirement in connection with certain trades and distributions of investment contracts pursuant to a now-repealed Alberta Securities Commission (**Commission**) policy.
- 3. Blanket Order *Disclosure of Executive Compensation and Indebtedness of Directors and Senior Officers* (the **1993 Order**), which was issued on 17 November 1993, permitted certain disclosure in prospectuses and other disclosure prescribed in now-repealed forms previously prescribed by Alberta securities laws.
- 4. Blanket Order 42-501 Section 213 of the Securities Act (R.S.A. 2000, c. S-4, as amended) and National Instrument 52-107 Acceptable Accounting Principles, Auditing Standards and Reporting Currency (the **2004 Order**), which was issued on 23 April 2004, exempted issuers other than investment funds from the requirements of certain now-repealed provisions of the Commission Rules (General).
- 5. Blanket Order *Exemption for Solicitations of Expressions of Interest* (the **2006 Order**), which was issued on 18 May 2006 to permit certain solicitations of expressions of interest, is superseded by provisions of National Instrument 44-101 *Short Form Prospectus Distributions* to similar effect.

Order

6. The Commission, considering that it would not be prejudicial to the public interest to do so, orders under section 214 of the *Securities Act*, R.S.A. 2000, c. S-4 that the 1983 Order, the 1990 Order, the 1993 Order, the 2004 Order and the 2006 Order are revoked with effect on 17 March 2008.
