This form is to be used by every individual seeking registration or approval from a Securities Commission in Canada and/or a self-regulatory body, or submitting an application for approval and authorization as a partner, officer or director of a broker or of an adviser with a Securities Commission in Canada
- 2. This form must also be used by an individual submitting an application for registration as a dealer or as an adviser with a Securities Commission in Canada.
- 3. All applicable questions must be answered. Failure to do so may cause delays in the processing of the application form.
- 4. This form and all attachments added to it must be typewritten. Any form or attachment completed by any other means may be considered not properly filed.
- 5. All attachments pertaining to any questions must be made exhibits to the form and each one must be so marked. All signatures must be originals; mechanical reproductions or photocopies of signatures will not be accepted. The Commissioner of Oaths before whom the application is sworn, as well as the applicant, is required to initial all attachments.
- 6. In completing the application, applicants should seek advice from an authorized officer of the sponsoring firm or from a legal adviser, if necessary.
- 7. One copy of the form shall be forwarded to the applicable Securities Commission in Canada. Members of the Investment Dealers Association of Canada and of the Alberta, Montreal, Toronto and Vancouver Stock Exchanges are require to file 2 signed copies of the application form with the self-regulatory body having audit jurisdiction over them.
