[1] This ruling addendum supplements the ruling issued by this panel on 13 March 2008 (the "Ruling", cited as *Re Arbour Energy Inc.*, 2008 ABASC 143) concerning certain issues of pre-hearing disclosure in respect of a proceeding arising from a twice-amended notice of hearing issued on 10 September 2007 (the "Notice of Hearing") by staff ("Staff") of the Alberta Securities Commission (the "Commission"), which set out allegations against Arbour Energy Inc.; Dennis Morice; Heinz Weis; Arthur Wigmore; Milowe Brost; The Institute For Financial Learning, Group of Companies Inc.; Merendon Mining Corporation Ltd.; and Gary Sorenson (collectively, the "Respondents"). This ruling addendum should be read together with the Ruling. Capitalized terms not defined below have the meanings ascribed to them in the Ruling.

A. Staff Assurance Concerning SEC Material

[2] In the Ruling (at para. 103) the panel directed Staff to advise the panel and the Respondents as to whether any terms or conditions on which they obtained the SEC Material from the SEC would preclude its disclosure to the Respondents on the terms set out in the Ruling. Staff have provided that advice, namely that there is no such impediment. Accordingly, portions of the SEC Material (and certain additional material formerly comprising part of the Sealed Nondisclosure) are being disclosed to the Respondents as contemplated in the Ruling.

B. Staff Work Product Redacted

[3] As mentioned in the Ruling, some of the SEC Material had attached stickers which for the most part appeared to indicate pages that had already been disclosed to the Respondents. Some of these stickers bore handwritten notations that appeared simply to be copying instructions. Those remain on the disclosable pages.

[4] However, some of the stickers bore other (or additional) handwritten notations that in our view amounted to Staff work product, which is not disclosable. In these cases, we removed the stickers bearing work product and substituted stickers of our own marked to indicate the redaction of a Staff sticker. It is in this form that the pages are being disclosed to the Respondents.

C. Schedules

[5] The attached schedules identify, by serial page number, those portions of the SEC material that are not being disclosed, or are being disclosed in redacted form.
