**Background**

1. On 8 December 2011 the Alberta Securities Commission (the **Commission**) issued an interim order (the **Interim Order**, cited as *Re OCI Q Corp.*, 2011 ABASC 615) pursuant to sections 33(1) and 198(1) of the *Securities Act*, R.S.A. 2000, c. S-4 (the **Act**) that:
  - (a) all trading in securities of OCI Q Corp. cease;
  - (b) the Respondents cease trading in all securities; and
  - (c) all exemptions contained in Alberta securities laws do not apply to the Respondents.
2. Staff of the Commission seek an extension of the Interim Order.
3. The Commission has received and considered documentary evidence and submissions.

**Order**

4. The Commission, considering it to be in the public interest, orders under section 33(3) of the Act that the Interim Order is extended until an enforcement proceeding is conducted and a final determination reached therein.
