ORDER
(*SUBSECTION 80.4(1)*)

1. WHEREAS the Act has been amended to include regulation of trading in exchange contracts, which amendments come into force October 1, 1992, pursuant to Orders in Council 520/92 and 521/92;
2. AND WHEREAS the amendments prohibit a registrant from trading in an exchange contract on behalf of another person or company on an exchange located outside of Alberta unless the exchange is recognized by the Alberta Securities Commission Board (the "Board") under section 80.3 of the Act;
3. AND WHEREAS the Board is satisfied that to do so would not be prejudicial to the public interest;
4. IT IS HEREBY ORDERED pursuant to subsection 80.4(1) of the Act that effective October 1, 1992 the following exchanges located outside of Alberta are recognized:
